CEDAR BEAN'S COFFEE JOINT – ARTIST PERFORMANCE AGREEMENT

This Agreement is made between Cedar Bean's Coffee Joint ("Venue") and the undersigned performer ("Artist").

1. Representations and Warranties

Artist represents and warrants that all music performed at the Venue will be:

- original work fully owned and controlled by the Artist, and
- free of any third-party copyright claims, unless otherwise disclosed to and expressly authorized in writing by the Venue in advance.
- Artist agrees not to perform any copyrighted cover songs at the Venue without prior written permission from the Venue.

Performing Rights Organization Disclosure

Artist agrees to disclose, prior to booking, any affiliation with a performing rights organization, including but not limited to Broadcast Music, Inc., American Society of Composers, Authors and Publishers, or SESAC, and to identify any repertoire that may be subject to such representation.

Artist agrees to notify the Venue immediately if any performing rights organization obtains the right to license public performances of Artist's repertoire at any time before the scheduled performance.

Artist represents that no performing rights organization is entitled to collect royalties for the live performance of the original works performed under this Agreement unless disclosed in writing to the Venue in advance.

Artist agrees that the Venue is relying on the accuracy of these representations in determining that a performing rights license is not required for this performance.

Artist acknowledges that any breach of these representations constitutes a material breach of this Agreement.

2. Limited Performance License

Artist grants the Venue a limited, non-exclusive, royalty-free license to:

- host and present Artist's live performance,
- promote the Artist's appearance using Artist's name, likeness, and images,
- record short clips for social media only if Artist consents, and
- post photographs or small excerpts (under 60 seconds) of the performance for marketing.

This license does not transfer ownership of Artist's music, publishing, or copyrights.

3. Indemnification and Defense

Artist agrees to indemnify and hold harmless Cedar Bean's Coffee Joint from any claims arising from:

- Misrepresentation of ownership of songs performed,
- Any unauthorized use of copyrighted works by the Artist.

Artist agrees to defend the Venue against any such claims and to reimburse the Venue for any damages, settlements, or legal fees incurred.

These obligations shall survive the performance and termination of this Agreement.

4. Compensation

Artist will be compensated as agreed upon between Artist and Venue.

5. No Recorded Music in Set

The Artist, including any accompanying musicians, collaborators, guest performers, substitutes, or opening performers, agrees not to perform or play any recorded music, backing tracks, loops, or audio samples containing copyrighted material unless expressly authorized in writing by the Venue.

6. Independent Contractor Status

Artist is an independent contractor and not an employee, partner, or agent of the Venue. Artist retains full control over the selection and performance of repertoire, subject to the terms of this Agreement.





7. Entire Agreement

This document represents the entire understanding between Venue and Artist regarding this performance.
